

TERMS OF BUSINESS (FOR PROMOTERS AND OTHER BUSINESSES)

Welcome to Mythology Agency ("We", "Us", "Our"). By engaging with our artists through our services, you ("Promoter", "Business", "You", "Your") agree to be bound by the following terms and conditions. These terms are in line with the guidelines provided by the Agents' Association of Great Britain.

1. Role and Services

Our principal role is to facilitate and enhance engagements between our artists and promoters, venues, and other business entities. Our services encompass, but are not limited to, the following:

- Booking Shows and Events: We specialize in orchestrating live performances for our artists, encompassing a wide array of events such as concerts, festivals, club gigs, and private engagements. This involves a multifaceted approach including:

- Domestic and International Bookings: We meticulously arrange performances both within the UK and internationally, ensuring that all logistical aspects, including travel, accommodation, and visa arrangements, are comprehensively managed.

- Venue Negotiations: We engage in detailed negotiations with venues to secure optimal performance dates, times, and conditions, ensuring that all contractual obligations are favourable to our artists.

- Facilitation of Contracts: We facilitate the execution of contracts for live show bookings, record deals, and other engagements between you and our artists. These contracts are executed directly between you and the artist; Mythology Agency acts solely as an intermediary to connect you with the artist and manage the negotiation process. Our role is to provide professional services that support and advance the careers of our artists while ensuring smooth and effective engagements with promoters and businesses.

By engaging with Mythology Agency, you acknowledge that we represent the interests of our artists but are not the artists themselves. Our role is to provide professional services that support and advance the careers of our artists while ensuring smooth and effective engagements with promoters and businesses.

2. Engagement Terms

By engaging with our artists through Mythology Agency, you agree to the following terms:

- **Contracts and Agreements:** All contracts for live show bookings, record deals, and other engagements will be executed directly between you and the artist. Mythology Agency acts solely as an intermediary to facilitate these agreements. Our role is to connect you with the artist and manage the negotiation process, but the contractual obligations and benefits are directly between you and the artist.

- **Payment Terms:** Payment terms for engagements will be outlined in the specific contracts between you and the artist. Mythology Agency will assist in ensuring that all financial transactions are handled smoothly and in accordance with the agreed terms.

- **Compliance with UK Statute:** Our services are provided in strict compliance with UK laws and regulations, including those pertaining to the provision of services, taxation, and contractual obligations. As a service provider, we adhere to all statutory requirements to ensure that our operations are lawful and transparent.

- **VAT on Services:** As a VAT-registered entity, we are mandated by UK tax law to charge VAT on our services. VAT, or Value Added Tax, is a tax applied to most goods and services in the UK. The prevailing rate of VAT is set by the government and may vary. Consequently, any fees charged for our services will include an additional amount to cover VAT, ensuring compliance with UK tax regulations and providing transparency in our billing process.

3. Limitation of Liability

Mythology Agency will not be held liable for any financial or legal responsibilities arising from the engagements between you and the artist, including but not limited to:

- Failure to fulfil contractual obligations.
- Mismanagement of funds.
- Any legal issues arising from the engagements.

4. Termination

Either party may terminate this agreement with three (3) months' written notice. Upon termination, any pending engagements or financial obligations will be addressed in accordance with the terms of the specific contracts between you and the artist.

5. Governing Law

This agreement is governed by the laws of England and Wales. Any disputes arising from this agreement shall be subject to the exclusive jurisdiction of the courts of England and Wales.

6. Amendments

We reserve the right to amend these terms at any time. Any changes will be communicated to you in writing and will take effect immediately unless stated otherwise.
